Adlerian Psychodynamic Psychotherapy; a means to „close the gap“ between patient`s deep emotions and reality requests. A clinical case will be presented.

Traumatic victimization and social sentiment

This work aims to explore the traumatic experience of an elderly victim of a predatory crime. The traumatic experience also triggers a sense of distrust and social isolation. In the Adlerian therapeutic setting it is possible to reactivate the social feeling of the victim, acting on the therapeutic function of encouragement.

From criteria-based diagnosis to finalism: the symptom as a driving force in Adlerian assessment and treatment design

This presentation will focus on generating interest and delivering impact, even for parents and caregivers with limited time for psychological study.

Subjectivity, early recollections, and socioeconomic status

This qualitative study employs adults' early recollections (ERs) to explore the intersection between individual subjectivity, lifestyle and culture, focusing on socioeconomic status (SES). Results urge appreciation of both class assets as cultural capital. Additionally, the study pioneers a framework for exploring cultural tendencies through individual ERs.

Closing the gaps with metaphors – An Adlerian Systemic approach

Metaphors are considered core elements to understand the patients' idiosyncratic interpretation of self, others, and the world (called private logic in Individual Psychology). One way of elaborating metaphors is the therapeutic work with early recollections and other projective techniques as the work with fantasies etc. An Adlerian-systemic approach can lead us to a deeper understanding of the individual's subjectivity and close the gap between their private logic and social interest. Based on the observation that the moments of deepest encounter and change are always preceded by experiences in which the completely unexpected and the strange breaks into the psychic and therapeutic space of the therapist, I would like to reflect on who this process occurs and what models are available to remain open and receptive to these processes.

Possibilities and limits of empathy

Adlers famous statement “looking with the eyes of another, listening with the ears of another, feeling with the heart of another” has become a guideline for many Adlerian therapists. Besides the question if this ideal is realistic similar to Bions “without memory and desire”, it raises the question whether it is really worth striving for. Is there not the danger of self-loss and/or fusion between therapist and patient. Perhaps it is important that the patient makes the experience of the otherness of the therapist in the sense of Levinas. I would like to discuss the theoretical and practical implications of this.

Democratic Leadership Revisited

Social interest and cooperation are far more common than antisocial acts. Yet those in power often are selfish, greedy, and corrupt. Such leaders appeal to the insecure, raise anxiety, selfishness, and susceptibility to populist propaganda. Responsible leaders increase community feeling, economic equality, and positive physical and mental health.

Hironori Nakajima & Takenori Masugami
Understanding and Resolving Harassment in workplace

JSAP launched EOLECT which aims to teach "social interest" and "courage" in 2022.

An analysis of participants' opinions about the educational impact of EOLECT revealed 95% of participants stated they developed a social interest during the program. We will present the background of EOLECT development and its educational effects.

Session 1.8 History and Future

Rainer Lemm-Hackenberg (German with english translation) The vast land of Individual Psychology – personally experienced

The lecture gives an overview of the development of content and organisation of the Individual Psychology in Germany. Children of the “digital age” have been immersed in the world of new media since their birth. It’s also through this “mediated experience” that they start to build the representation of themselves and the world, “feeding” on multimedia products. What processes of identification and understanding of self, the other and the world happen through these channels of experience? How can the child psychotherapist use these new types of storytelling during the sessions?

A Case Study: How does the Experience of Abuse Affect Lifestyle?

In this presentation, we will trace the counseling process of a client whose parents abused her from childhood to adulthood for more than ten years and examine the changes in her lifestyle from the perspective of Adlerian psychology. This case study will illustrate how the client handled her abuse experience.

Moving Beyond Addiction and Trauma: Reconnection, Recovery and Experiencing Awe

Understanding addiction requires examining the role of trauma in contributing to initiating and maintaining addiction. An Adlerian perspective of going beyond the symptoms will provide a path to reconnection and engagement that provides a fertile environment for experiencing awe. Experiencing awe is an important form of self-care for addiction.

Are they really the “Others”? – Reflections on the action-based organization of the relationship between research and clinical practice

This paper examines the gap between psychodynamic theory and practice in psychotherapy, focusing on the challenges of the integration of clinical experience and research. It addresses how practitioners' insights can inform scientific discourse and vice versa, and discusses tensions and barriers in this transfer process. Drawing on interdisciplinary perspectives, the focus is on methodological approaches for bridging this gap.

Case study: Understanding the strangeness within me

Personal and transgenerational trauma led to a feeling of alienation and severe depressive states in a 76-year-old patient. As part of the psychoanalytic process, unconscious dynamic connections could be recognized and processed. The patient can express her own emotional experience and deeper understanding through creative and playful forms. The resulting pictures partly reflect experienced German history. The article focuses on transgenerational traumatic aspects.

AI instead of couch? ChatGPT and the question of the nature of psychotherapy (German with English translation)

With the publication of the AI language model ChatGPT3, a media discussion arose about fundamental changes in our professional world through artificial intelligence. According to various contributions to the discussion, the use of AI models in the treatment of mental illness is also conceivable in the future. What considerations are being made in this regard? On what ideas of mental illness and psychotherapy are such attitudes based? On the importance of a psychodynamic perspective in the debate.

Almuth Bruder-Bezzel

Personality as image and as artist

This Adlerian conviction that the individual is caught between creativity and determination needs to be investigated and questioned. Far-reaching socialization influences from the beginning of life, as well as further standardization influences and even propagandistic manipulation, shape our mental life. How much is left for the individual and the unique? And do these two forces not also call into question the unity of the individual? The aim of therapy would therefore be to eliminate what is foreign in us and to develop what is our own.

Dependence in the couple relationship – cultural heritage or lifestyle?

Case vignette of a second-generation migrant

In this workshop, the topic of “relationship dependence in the couple relationship” is discussed against the background of a culturally-dominated lifestyle and how to work through it. Women from other cultures in particular tend to think of family tasks as their own goals. This results in the difficulty of not being able to differentiate yourself from people who are close to you and who are demanding.

Alberto Malfatti

Personal values and reference culture

I propose in this paper a case-study of a “second generation” girl, with a transcultural point of view, for the patient and the therapist. The central point of the clinical case concerned the construction of the own identity, complicated by the distance of the cultural context.

Candace Sneed

Ethical integration of Religion and Spirituality into Clinical Work and Supervision – a conceptual model

In this workshop, presenters will explore religion and spirituality as an aspect of lifestyle and holistic conceptualization, ethical considerations for appropriate application of a religious and spiritual lens in clinical work and supervision, explanation of how to introduce religion and spirituality into a clinical or supervisory discussion, and how to incorporate religion and spirituality into a professional conversation/assessment interview.

Session 2.4 Overcoming

Gian Piero Grandi The Winter Soldier

The world's winter leads us to discover anxieties and distress masked as boredom and a lack of desire. People seem to be governed by passivity and an excessive need for control, leading to rumination and faded, poorly elaborated thinking. The psychotherapist witnesses the renewal of the therapeutic process, as we believe that the therapeutic relationship itself can rekindle the warmth of human encounter.

Daniela Čechová & Kristina Široká Psychological Immunity in the context of Adlerian Theory

The theoretical model of the psychological immune system by A. Oláh is presented. Psychological immunity protects individuals from the negative effects of stress and promotes their mental health and well-being. The psychological immune system consists of sixteen cognitive, behavioral and motivational personality dimensions, which are grouped into three subsystems. In addition, psychological immunity can be measured with the Psychological Immune Competence Inventory, which allows the creation of personalized profiles of specific strengths and weaknesses to enable prevention and effective and targeted support. This model can be seen as an extension of A. Adler's concept of mental health.

Workshop: Ludo ergo sum

Sabine Tibud & Bettina Meisel Ludo ergo sum – I play, therefore I am ... child analyst

The lecture tries to show, supported by a survey of experts, that child and adolescent psychotherapists specifically need their own experiential spaces in their training in order to be able to "experience" their psychoanalytic play competence or their profession-specific method of cognition, relationship and dialogue "at first hand". In order to recognize this central aspect of the professional action system of an analytic child and adolescent psychotherapist and to integrate it into the content of the training, in the view of the speakers the classical teaching analysis had to be supplemented by their own profession-specific self-experience in and with play. For this purpose, they present a practiced and evaluated self-awareness concept - "Teaching years are play years" - which has been practiced at the Alfred Adler Institute Aachen-Cologne since the year 2010.

Resilience Focused Counseling & Therapy: Toward the further evolution of Adlerian's IP

Adler emphasized the importance of movement from minus to plus. How can Self and Others representation change through psychotherapy. A process study.

A research study in psychotherapy is presented to test the relationships between patients' Self and Others representations and therapists' techniques and emotional response during a time limited (40 sessions) treatment of Adlerian Psychodynamic Psychotherapy (APP). Background: Dysfunctional perceptions of oneself and the others are considered as a core psychopathological factor; consequently, their variations can also be assumed as a core indicator of psychotherapeutic process and outcome.

The functioning of the Self in adolescents with psychopathology

An in-depth psychodynamic exploration and interpretation of current obstacles to adolescence at the light of the process of self-development is necessary to face this phenomenon and improve prevention strategies directed to help adolescents reduce the effects of recent social changes.

Marinus Wisböck

**From pain to symbol. The search for the helpful common ground
(German with English translation)**

Against the background of concepts of countertransference, symbolization ability and psychological pain, the paper asks how these concepts are related in high-frequency work with an adolescent patient. The possible correlations are presented on the basis of case work and related to the fact that the treating therapist is at the beginning of his clinical work activity. The special challenges that can arise in the treatment of patients at the beginning of their practical work and how these influence the therapeutic process are worked out.

War related Trauma: case from Ukraine

Refers to the psychological reactions to a traumatic event that affect an entire society; it does not merely reflect an historical fact, the recollection of a terrible event that happened to a group of people. It suggests that the tragedy is represented in the collective memory of the group, and like all forms of memory it comprises not only a reproduction of the events, but also an ongoing reconstruction of the trauma in an attempt to make sense of it. Collective memory of trauma is different from individual memory because collective memory persists beyond the lives of the direct survivors of the events, and is remembered by group members that may be far removed from the traumatic events in time and space. Reasons for presenting this case: client whose presentation featured war-related trauma; demonstrates the importance of telecounselling; highlights the need to make meaning of events in period of uncertainty; collective trauma representation?

Session 3.3 Work with LGBTQ+ (two sessions)

Martina Stang & Aleš Vápenka
Working group – casuistic-technical seminar (CTS) – psychotherapeutic work with LGBTQ+ clients

The specifics of the psychosexual development of non-heteronormative identities and the needs of non-heteronormative people and their special experiences of discrimination and violence are still rarely addressed in psychotherapy training and supervision. This often leads to stagnation or even to the termination of treatments. We would like to have space for joint reflection also on the transference-countertransference constellations depending on the identity of the treating person.

Session 3.4 Beyond symptoms

Julia Yang Blagen
Individual Psychology as a social Medicine: Self and Collective Health and Healing

Adler's earliest work was conceived as social medicine with the idea that disease can be a product of society. In our present chaotic time, IP practitioners must be prepared to respond to acute and chronic consequences of individual and collective trauma. This program will present the new mind-body medicine practices.

G.G. Rovera, A. Bianconi, L.C. Milito and S. Fassino
Dynamics of shame and self-compassion in narcissistic disorder according to Individual Psychology. Clinical examples.

Narcissistic personality traits are increasingly common in Western societies and are closely linked to varying degrees of empathy. These traits contribute to both prosocial and antisocial behaviors. Narcissistic personality disorder (NPD) often involves emotional fragility masked by arrogance and rooted in a "Shame complex" similar to Adler's "Inferiority complex". Recent brain imaging studies suggest that developing self-compassion goes beyond mere empathy and aids in emotional repair. The concept of self-compassion involves multiple facets and serves as both a precursor and an outcome in the therapeutic process. Training should focus on enhancing skills and attentiveness of potential side effects and defenses, thereby fostering a more effective therapeutic environment.
